


Recommendation

Approve Special Events Permits for the Knights of Columbus as described below. Prior stipulations made between the City and Knights continue in effect.

Background

Event Description:

1. Weddings and 15-year-old parties on 6/26/10, 7/17/10, 7/31/10, and 8/7/10 from 2:00 p.m. to 2:00 a.m..
2. Application is for malt, vinous and spirituous liquor
3. Location will be at the Knights of Columbus facility at 1112 8th Street

Factual Findings

- Applicant has possession of the premises through a deed.
- Applicant qualifies as a non-profit corporation.
- Applicant has certified that this permit is needed pursuant to CRS 12-48-103.
- The application was submitted in a timely manner.
- All applicable fees have been paid.

Stipulated Conditions

This organization has agreed to voluntarily accepting the conditions in the attached letter.

Judy:

The purpose of this letter is to add additional mandates and restrictions to both the application process and liquor license protocol, to future special events applications for the Knights of Columbus facility here in Alamosa, Colorado. These points were agreed upon in meeting between Gabe Atencio and Leroy Medina on 2/25/10.

The Knights of Columbus facility has for years been applying for special event permits, which usually include the right to sell liquor/alcohol. In the time that I have been the Chief of Police, we have seen numerous instances where there have been fights and/or disturbances that can be directly attributed to both the sale of liquor/alcohol on premises and/or an overcrowding of people in the facility. Frequently, there have been instances that have gone out of control. On one occasion, in the Summer of 2009 the disturbance grew to where one person attempted to run over another person and actually struck the building with their vehicle.

Here are the mutually agreed upon points:

- Arrangement for a minimum of two police officers, three personnel if using GWI Security personnel, to work all evening events.
- Off-duty police /Security coverage will be coordinated prior to the special events application being filed with the City Clerk, typically 45 days.
- All liquor/alcohol sales will cease at 0100 hours.
- The Alamosa Police Department, at a supervisory level, retains the capacity to cease alcohol sales if the security and safety of the event become compromised.
- Knights of Columbus personnel will abide by all alcohol/liquor laws to ensure that no person, under the age of 21, is served alcohol/liquor.

I am concerned, for both the safety of the people who are attending these events
